1 Minutes of Last Meeting

The minutes of the committee meting held 4th September 2023 had been circulated and there were no items that would not be covered elsewhere on the agenda.

2. Treasurers Report

JF reported that the current account balance stands at £1659 and the business savings account at £1060. 8 Membership

9 Kent Committee

- a) In preparation for the AGM on 28 January formal notice will be sent to members in early December. RA will liaise with Andrew
- b) RA confirmed that he would be standing down from the committee at the AGM. JF, WE, JM and JE had all confirmed that they would continue subject to member approval. RA reported that there were 4 names as possibilities for committee vacancies and if all were confirmed an election would be required at the AGM. It was agreed that when it comes to the appropriate item on the AGM agenda that each name, existing and new, would be considered individually rather than "en-bloc"
- c) It was agreed that further consideration of the matrix of committee members duties and responsibilities should be left until after the AGM.

10 Wider promotion of the Group, the Society and our activities

RA tabled a paper based on ideas and suggestions on wider promotion that David Groves had submitted. Originally David was to have attended the meeting. In discussion a number of the suggestions were found to be in practice already either as-is or with a different emphasis. It was agreed that the following be followed up in the first instance by the new committee:

- In our Group welcome letter to new members ask for information from the new
 member about what was it that affected or promoted their decision to join the Society.
 This information could be helpful in our targeting group activities and events.
 Information from National tend to only give where they found out about the Society
- Assess what members want from the Group and do they perceive of any weaknesses at present. RA noted that we conducted a survey of group members several years ago and it was agreed another survey should be carried out. RA will source the original survey
- O Ask members, in the survey, if they have a (portable) layout and would they be prepared to exhibit at a group event or on behalf of the group at an external event.
- O DG had mentioned that conversation with visitors at shows is always a good idea and promotes activities. It was felt that we did this already but if manning resources allow, and they don't always, have a member "front of house" to talk with visitors

One suggestion that DG made was to encourage members to assist more at exhibition. All present felt that this continues to be an issue with requests for help usually being answered from the same small band of people. Some members had told us in the last survey that they didn't have a particular interest in the group; they had joined the National G Scale Society.
